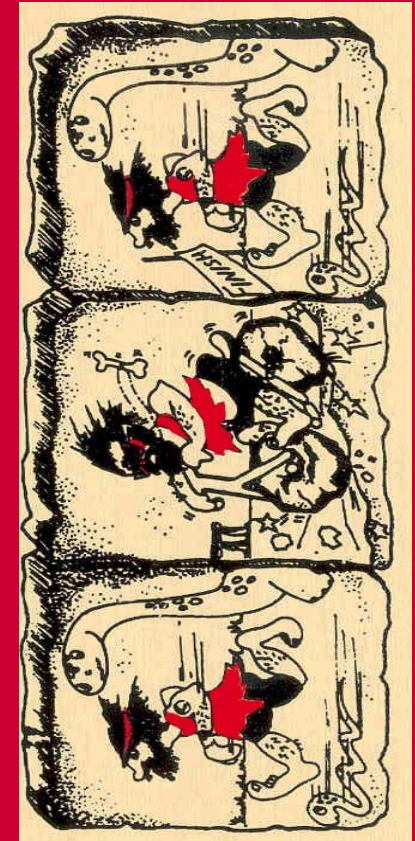

Race Pack Pickup:

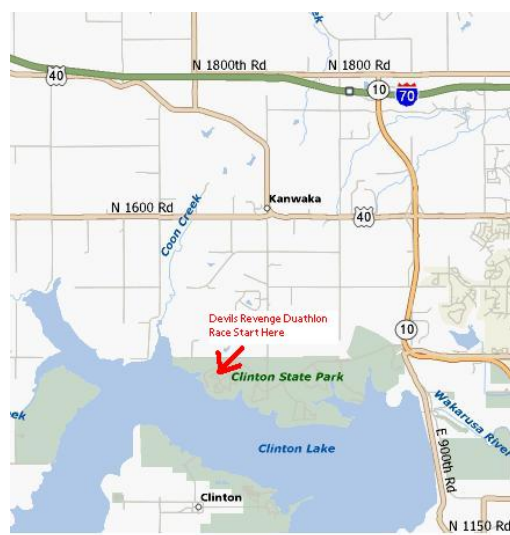
Race packets can be picked up on race day morning at the registration tent.

I agree it is my sole responsibility to be familiar with all courses, and special regulations of the event, and my ability level. I understand and agree that situations may arise during the event and I must continually ride/run so as to neither endanger myself nor others. I accept full responsibility for the condition and adequacy of the equipment, which I use (including, but not limited to the helmet and the bike).

I agree for myself and my successors, that the above representation are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the party or parties in defending. This agreement may not be modified orally.

Having read this release and wavier, I, for my behalf waive and release and agree to indemnify and hold harmless the events management, sponsors, agents, representatives and successors from all claims or liabilities of any kind arising out of my participation in this event.
